Applicability:

City of Chandler Zoning Code: 35-305(4)

- 1. Entertainment activity shall require a use permit, when all of the following criteria are met:
 - i. Entertainment activity, as defined in section 35-200, is provided, or outdoor seating with external speakers is provided; and
 - ii. Alcoholic beverages are sold or served; and
 - iii. If live entertainment is not provided outdoors, the property is located six hundred (600) feet or less from a residentially zoned property. Said distance shall be measured from the closest exterior wall or fence of any indoor or outdoor space occupied by the subject establishment to the closest property line of a residentially zoned property; and
 - iv. If live entertainment is provided outdoors, the property is located one thousand three hundred and twenty (1,320) feet or less from a residentially zoned property. Said distance shall be measured from the closest exterior wall or fence of any indoor or outdoor space occupied by the subject establishment to the closest property line of a residentially zoned property.
- 2. A property with a current liquor use permit shall not be required to obtain an entertainment use permit, unless subject to a condition of approval related to a time limit. Liquor use permit conditions related to entertainment activity shall remain in effect.

Entertainment activity: live musical performances, disc jockeys, karaoke, dancing, and similar activity. This definition excludes establishments that provide other types of entertainment activity as the principal use such as a cinema, a performing arts theater, amusement arcade, bowling alley, skating rink, or recreational assembly uses for families and/or children.



Entertainment Use Permit Submittal Checklist

Submitting an application online:

- 1. Go to https://developmentpermits.chandleraz.gov/clics/
- 2. Log in, or register for an account if you are a new user
- 3. Under the "Planning" tab, select "Create an Application", choose the appropriate bullet point
- 4. Continue application and provide all required information, upload all of the required documents listed below and pay the application fee

Required electronic documents:

Submit ONE ELECTRONIC COPY of all of the following documents in 8 $\frac{1}{2}$ x 11 or 11 x 17 sheet sizes. All plans and elevations must be to scale. After initial review, the assigned Planner may request additional information or documents that are not listed below.

Letter of Authorization (only required if the applicant is not the property owner)

Written narrative that describes the proposed business requesting an Entertainment Use Permit.

Include specific details such as:

- Property address and suite number(s), if applicable, shopping center or project name
- Business name, applicant's name and contact information, hours of operation, days of the week business is open, number of employees, copy of menu if available
- Type of entertainment provided (i.e., live music, pool tables, televisions, speakers, music, live musical performances, disc jockeys, karaoke, and dancing)
- Building/tenant space square footage, outdoor dining areas or patio square footage
- Discuss access to and from the patio, number of outdoor speakers and/or TVs,
- Total number of seats provided indoors and outdoors
- How does the patio comply with the Smoke Free Arizona law.
- Discuss any site improvements related to this Entertainment Use Permit such as patio or building expansion, landscaping, modifications to the building architecture, parking, pedestrian access, patio fencing
- Building signage and/or monument signage
- Provide any other details about the type of business requesting the Entertainment Use Permit and how it relates to the surrounding area/tenants.
